#### 1. Introduction

### 2. Purpose of this policy

## 3. Data protection laws

We process your personal data in line with UK laws and regulations and more specifically The General Data Protection Regulation (GDPR)

#### 4. Consent

Under GDPR, consent should be given in a positive and affirmative way by individuals who share their personal data with organisations. According to the European Data Protection Directive, consent means: "any freely given specific and informed indication of his wishes by which the data subject signifies his agreement to personal data relating to him being processed."

When you submit your personal data on the website, you need to submit it along with your affirmative consent. We will also record your consent.

#### 5. Personal data collected

We gather a certain amount of personal data from the website. We only collect the personal data that you directly submit to us through the "contact us" form.

The data collected includes all of the following:

First name, Surname, Phone number, Address and a summary of your enquiry.

Morgan Law collects this data so as to be able to contact you once you have submitted a request.

#### 6. Data usage

The following details how we use the data that you have submitted to Morgan Law through the website:

Understand your needs and whether we may be able to help you.

- Contact you with regards to the query you have submitted
- Provide you with information as to how the firm may be able to help you
- Confirm what is required so that the firm can provide you with advice

# 7. Third parties and overseas transfers

When your personal data needs to be transferred to an overseas country that is not part of the EEA (European Economic Area), we will always ensure that there are adequate levels of protection and a similar legislation with regards to data protection. Each country might have different laws and regulations with regards to data protection, however there are some agreements in place, e.g. the privacy shield for the United States of America. Overseas transfers will only be possible when we have your prior affirmative consent to process your personal data. We will contact you to obtain such consent when required.

# 8. Data security safeguards

You have several rights with regards to your personal data under GDPR. You can submit a "subject access request" if you wish to obtain a copy of all the personal data we hold about you. You can request to have your personal data updated and you can also require to have your data deleted and not be further processed. You can also request to have your personal data transferred to another controller.

### 9. Your rights under the General Data Protection Regulation

Under the GDPR, you have all the following rights:

- The right to rectification
- The right to access
- The right to erasure
- The right to restriction
- The right to object
- The right to lodge a complaint
